

#### **<u>President's Message</u>** Jane Adrian, Co-President



I cringed when in Manchester, New Hampshire, on February 2, 2016, the revered Secretary of State (1997-2001) Madeline Albright addressed supporters for Hillary Clinton's Democratic nomination for President (see here), and in a moment of

exuberance delivered a rendition of a line that that served her for nearly twenty-five years: "There's a special place in hell for women who don't help each other."

Not that the words had lost the sentiment that have, in the past, inspired many to action, but the place and time were wrong— all wrong. This misstep resulted in a brouhaha in which the younger women, whom Secretary Albright addressed, interpreted her words as a particular invitation to hell.

And we wonder why members run in droves away from leadership positions? People do not want to accept leadership positions because of the time and impact on personal and family lives and because of the way we expect our leaders to be perfect and right each and every time.

While any leadership position will lead to a sense of fulfilling satisfaction and meaningful service, each tenure is as likely as well to result in some difficult moments, embarrassing situations, and perhaps even a period of organizational or situational turmoil. To let the opportunity pass represents certainly the path of least resistance.

The decision to step into a leadership position requires sacrifice and takes real courage, especially when the s\*\*t hits the fan and may require a strong resolve to confront ethical breaks and bullies. Of the list of reasons members may shy from leadership positions, reasons such as the considerable impact on personal lives and families, fear of being criticized or disliked, the frustration and challenge of dealing with dissent, conflict, tensions and inevitably, one's own missteps, the most unenviable is dealing with the fallout of one's own mistake. The circumstances, the structures, naivety, ignorance, and miscommunication are often the center of the cause.

So one week later when My Undiplomatic Moment by Madeline Albright appeared in the New York Times, I cheered.(see here). Secretary Albright, in the spirit of a true and inspirational leader, acknowledged her misstep and apologized, "I should know better than to tell a group of women to go to hell." She then reiterated the intent of her belief that, "Even today, women have an obligation to help one another. In a society where women often feel pressured to tear one another down, our saving grace lies in our willingness to lift one another up."

Issues of work-life balance, gender and equality in elected offices and the workforce, equal pay for equivalent work, paid family leave, sexual abuse, and access to healthcare including contraception remain in the forefront in spite of over a century of

It is our hope that these programs empower the women of Arizona. With this in mind, we ask: what do we do next? How do we reach more members? Are we all ready to be a part of this mission?

#### **The AAUW Fund Explained**

#### by Karen Ramos

The AAUW Fund is the general fund of the organization. It is the name used to identify the aggregated unrestricted funds that supply full or partial funding for every AAUW program except for our Fellowships and Grants. Many of AAUW's most popular programs, such as Elect Her, \$tart \$mart, and the Two-Minute Activist, are solely supported by the AAUW Fund. Several programs, such as the Legal Advocacy Fund and our Research, receive partial support from both the unrestricted AAUW Fund and partial support from restricted gifts. By contrast, our Fellowships and Grants are supported entirely by interest from the AAUW Endowment, which consists of restricted funds. Thus, contributions to the AAUW Fund are critical to sustaining program growth and responding to increasing member demand for highquality mission-based programs.

In discussions with members and branch and state leaders, it became apparent that there is confusion about how AAUW programs are funded. A new diagram was developed that demonstrates the types of programs that are funded by the general fund. In 2015, AAUW Arizona members donated. \$27,628 to support the AAUW Fund. #### **Two Sides of a Coin** By Joanne Walen

You may have received a solicitation, possibly from an insurance company such as Nationwide, directed to you because you are an AAUW member, and you may have wondered about the source. Mail of this sort is often an annoyance and results in an uncomfortable feeling of vulnerability. You may ask yourself, "How do I know that the company's claim that I qualify (because I am an AAUW member) for a group discount and that the discount is, in fact, true and legitimate? Does AAUW perhaps maintain a list of those commercial entities with which the

organization has an agreement, so that I might verify the trustworthiness of the solicitation?"

Jane Adrian and I have investigated these solicitations in relationship to AAUW's privacy policy and have received an email from Linda Hallman CAE, Chief Executive Officer, assuring members that they can opt out of external marketing promotions by contacting <u>connect@aauw.org</u> and making the request in writing. Please specify that you want to opt off the lists shared with commercial entities through AAUW's external marketing and agreement only and that you still want to receive emails related to AAUW organizational mission. Unfortunately it is not a simple one-click step. You must do it in writing.

Those members who wish to verify that current marketing agreements are legitimate may access the website http://www.aauw.org/membership/ benefits/. Scroll to the bottom of the "Benefits for AAUW Members" page to see a list of affinity partners and to access coupons and a number of discount offers. Please note when an AAUW member subscribes to services provided by those contracted companies, AAUW receives royalties that are deposited in unrestricted funds and are used to support a multitude of AAUW programming. <u>http://</u> www.aauw.org/files/2014/11/The-AAUW-Fund-Diagram.pdf For additional frequently asked questions and answers about AAUW Funds, please consult http://www.aauw.org/resource/the-aauw-fundfag.

You may wish also to the review the Privacy Policy (http://www.aauw.org/privacy-policy/) which documents that AAUW exchanges "names of potential supporters" with "like minded" and similar groups, for the "purposes of growing AAUW programs and services."

For those who wish to remain open to receiving solicitations from AAUW affinity partners, Linda notes, "These business agreements benefit members and bring much-needed unrestricted dollars that support the many programs AAUW is producing." That said, Linda at the same time assures us, "If members want to opt out we will absolutely make that happen — they should contact Connect. They are the go-to resource at all times."

#### In Memoriam: Violet Larney, 1920-2016 by Joanne Walen

Violet Larney, founder and first President of the East Mesa branch of AAUW, passed quietly into eternal Life the morning of February 11, 2016. Born in Chicago on May 19, 1920, Violet Hachmeister, an only child, excelled in school and was proficient in music and mathematics. She was able to read music before she could read words, learning to play the piano at the age of five. She graduated from high school as Valedictorian in 1938, going on to Illinois State Normal University to major in mathematics (against the advice of her professors and advisor), receiving her B.Ed and later her MA at the University of Illinois. She spent two years teaching high school mathematics and accounting, then moved to the University of Wisconsin as a Teaching Assistant and later an instructor in the Extension Division while taking graduate courses in mathematics. She received her Ph.D. in mathematics in 1950, along with a second degree: a Mrs. She and Norbert Larney were married that year.
